



**MEMORANDUM OF UNDERSTANDING
BETWEEN
DIPONEGORO UNIVERSITY, INDONESIA
AND
UNIVERSITY OF LINCOLN, UNITED KINGDOM**

Considering their common interest in establishing and facilitating cooperation in academic and scientific related activities, Diponegoro University and the University of Lincoln, intending to record this mutual agreement in a Memorandum of Understanding, hereby conclude this agreement:

**ARTICLE 1
OBJECTIVES**

The objective of this cooperation will be a focus on promoting both academic research and enhancing educational opportunities for students and staffs.

**ARTICLE 2
SCOPE OF ACTIVITIES**

Within the fields to be mutually designed to promote the cooperation prescribed in Article 1, both institutions agree to the following general forms of cooperation:

- (1) Joint programmes for education and research, including conferences and meetings
- (2) Exchange of academic staff, researchers and students for study and research
- (3) Exchange of information in the fields of interest to both institutions
- (4) Other activities mutually agreed upon by the two institutions.

**ARTICLE 3
PLAN OF OPERATION**

A detailed description of the scope of activities shall be defined in a written agreement which will constitute an integral part of this Memorandum of Understanding and be signed by both parties.

**ARTICLE 4
CONTRIBUTION BY
DIPONEGORO UNIVERSITY AND THE UNIVERSITY OF LINCOLN**

This memorandum of understanding shall not bind either institution to any financial commitment. Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon a case-by-case basis in separate plans of operations.

**ARTICLE 5
SETTLEMENT OF DIFFERENCES**

For the avoidance of doubt, this MoU is not intended to be legally binding. In cases of dispute that arise in the administration of this MoU, both parties will consult with each other and attempt to resolve the matter through negotiation in good faith.

**ARTICLE 6
AMENDMENTS, DURATION AND TERMINATION**

1. Amendments to this agreement may be made upon mutual agreement of both parties
2. This agreement shall become effective on the date of signature by the representatives of Diponegoro University and the University of Lincoln, and will be effective for a period of five years. The period of validity maybe extended upon mutual agreement of both parties
3. This agreement may be terminated upon six months' written notice by either side. It shall be subject to review in five years and shall be extended after mutual agreement.
