



**MEMORANDUM OF UNDERSTANDING
BETWEEN
TECHNISCHE UNIVERSITÄT DARMSTADT,
FB (FACH BEREICH - ARCHITEKTUR) 15 - GERMANY
AND
DIPONEGORO UNIVERSITY – INDONESIA**

The parties to this agreement, Professor Dr. Hans Jürgen Prömel, President of the Technische Universität Darmstadt (TU Darmstadt), Darmstadt, Germany

and

Professor Sudharto P. Hadi, MES., PhD, Rector of the Diponegoro University, Semarang, Indonesia

Hereby confirm their commitment to respect this agreement on the following terms:

Article 1

The Technische Universität Darmstadt, FB 15 and Diponegoro University agree to carry out activities to develop program of common interest in the field of teaching and research, and will approve the means for the attainment of the objectives set out in this present agreement.

Article 2

The Agreement is in respect of:

1. The exchange of student carried out on the basis of the principle of reciprocity;
2. The exchange of specialist for periods to be defined, for the purpose of common scientific research;
3. The defining of research themes and setting up of joint teams to work on them;
4. The setting up of joint conferences and seminars;
5. The exchange of research and scientific materials, publications and information;
6. The sharing of expertise and initiatives in the interest of both institutions.

Article 3

The fields concerned are:

1. Urban Planning and Development
2. Urban and Regional Studies

And any other field can be added by an additional agreement to the present agreement.

Article 4

A commission to co-ordinate common project will be set up in both institutions. It will oversee the fulfillment of this agreement and co-ordinate the undertaken projects. The project and actions must comply with the statutory norms of both institutions.

Article 5

A specific additional agreement to this agreement can be drawn up annually. The specific agreement will include the details of the actions and provisional budget to be submitted to the approval of each institution.

Article 6

The exchange of teachers and students will be carried out on the basis of the principle of reciprocity. Both institutions will endeavour to obtain financial means from their own budget, or that other institutions or organizations in order to meet the costs arising from these exchanges. Tuition fees will be paid by students in their home university, with exception of foreign languages courses. Entrance fees will be paid by students.

Article 7

Both Universities will endeavour to bring about research co-operations by regular exchange of documentations, publications and educational material within the regulatory framework in force in both countries.

Article 8

The present agreement shall remain in force for five years. It may be renewed on the same terms, or on such as may be agreed by the two institutions and authorized by any approving authorities.

Article 9

The present agreement can be revoked with at least six month notice by either party, without prejudice to the activities that might be under way.
