



MEMORANDUM OF UNDERSTANDING
between
ISTANBUL AYDIN UNIVERSITY
and
DIPONEGORO UNIVERSITY



ISTANBUL AYDIN UNIVERSITY, a privately owned institution of higher education having an address at Sefaköy Beşyol, Florya, Küçükçekmece, İstanbul, Turkey

and

DIPONEGORO UNIVERSITY, an institution of higher learning established pursuant to the provisions of Government Decree No. 7 Year of 1961, state university, whose address is at Kampus Tembalang, Semarang 50239 Central Java, Indonesia Tel +6224 7460012 Fax. +6224 7460013.

The two parties believe that the process of the university education can be enriched and international understanding strengthened, and wish to establish relations between the two institutions, hereby agree to cooperate with each other in areas of common interest as follows:

1) The participating institutions shall endeavor to promote collaboration through a broad range of activities such as:

- a.** Student exchanges;
- b.** Student admission procedures and conditions;
- c.** Acceptance of the approved coursework and credits;
- d.** Summer Study Abroad Programs;
- e.** Faculty member exchange for short-term and, as funding and other circumstances permit, long-term visits;
- f.** Collaboration on research projects; organizing joint seminars, conferences;
- g.** Joint and dual degree projects in regard with associate/undergraduate/graduate programs, and curriculum articulation and development projects to this end.


2) The terms of cooperation for each specific activity implemented under this Memorandum of Understanding shall be mutually discussed and agreed upon in writing both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this Memorandum of Understanding.

3) Financial and/or funding consideration shall become the subject of specific discussion and agreement within the framework of separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended and implemented.

4) This agreement shall remain in effect and continue in force for a period of 5 years from the date it is signed by duly authorized representative of both parties. Furthermore, this agreement may be renewed every 5 years unless one side presents a written notice of intention to the other not to renew, 6 months before the date of expiry. The Memorandum of Understanding may be amended or extended by mutually written consent of the authorities of the two parties.

5) The Memorandum of Understanding as outlined in this document is meant to describe the nature and cooperative intentions of those institutions involved and suggest guidelines for cooperation. Nothing, therefore, shall diminish the full autonomy of either institution, nor may constraints be imposed by either upon the other.
