

MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION

BETWEEN

GRAND VALLEY STATE UNIVERSITY (GVSU)

Allendale/Grand Rapids, Michigan, USA,

and

DIPONEGORO UNIVERSITY (UNDIP)

Semarang, Indonesia



Grand Valley State University and Diponegoro University, seek to establish a General Agreement to foster international cooperation in education and research.


1. Both parties agree to encourage the following activities, in particular to promote international academic cooperation:
 - (a) Student and/or academic and administrative staff exchanges;
 - (b) Joint research activities;
 - (c) Collaborative professional development;
 - (d) Exchange of publications, reports and other academic materials and information and
 - (e) Other activities and programs in areas of mutual interest, benefiting both parties.

Before these activities can be implemented, both parties shall discuss mutual needs and opportunities and enter into separate specific agreements based on mutually agreed upon objectives and outcomes

2. This General Agreement shall be applicable to the educational and research organizations attached to each party.
3. This Agreement is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and help develop a genuine and mutually beneficial exchange process/research relationship, that will ideally result in a formal exchange and partnership agreement at some point in the future.
4. This General Agreement shall become effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.
5. This Agreement should be reviewed every five years to evaluate the progress and the quality of the mutual cooperation. The Agreement may be extended for additional five year periods upon the written consent of both parties. If the Agreement is not renewed by mutual consent, the Agreement will conclude at the end of the specified time period, or after activities in progress have concluded
6. This Agreement may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination of this Agreement shall be permitted to conclude as planned unless otherwise agreed.

7. The parties subscribe to a policy of equal opportunity and do not discriminate on the basis of age, color, disability, ethnicity, gender, gender identity, height, marital status, national origin, political persuasion, race, religion, sexual orientation, veteran status, or weight.
8. Each party shall designate a person of office to serve as liaison for implementing this Agreement.
